Terms and Conditions

"Things to Know before you go"

The Purchase of packages:

Herein after referred to as the "services" offered by Mexico Yacht Vacation constitutes a contractual agreement between Mexico Yacht Vacation and the customer this also implies your acceptance to Mexico Yacht Vacation's Terms and Conditions described in the section "Things to know before you go" and other terms and conditions. Please ensure and read carefully and understand these terms and conditions prior to booking.

Deposit:

At time of booking, customers must provide Mexico Yacht Vacation with a deposit of \$880.00 USD. We accept credit card, money order, or certified check. All deposits are 100% non-refundable. Any refunds requests will be at the discretion of Mexico Yacht Vacation and will depend on the nature circumstances. Under certain circumstances reservation dates can be transferred.

Payment by Credit Card:

Verbal Authorization by the customer to an agent of Mexico Yacht Vacation for the use of a credit card confirms the reservation whether or not the draft has been signed. However upon request by the agent of Mexico Yacht Vacation, customers must submit in writing that the credit card may be used without their signature.

Prices Indicated:

All prices, either found on the internet, brochure, newspaper, etc bearing the name Mexico Yacht Vacation, are quoted in American Dollars unless otherwise indicated and are based upon the prices of service providers, exchange rates, cost of fuel, taxes, and other fees in forced at the time of preparation of the present brochure. All prices are valid upon date of publication and are subjected to change without notice. Price reductions are applicable to new bookings only.

Reservations and Confirmations:

Reservations are kept strictly confidential. Any and all personal information will not be shared with 3rd parties without the agreement of the client. Reservations are strictly personal and must be accompanied by an \$800.00 USD deposit or payment in full before reservations can be confirmed. Reservation Date changes will be at the discretion of Mexico Yacht Vacation depending on the circumstances.

Final Payment:

Unless otherwise indicated, final payment must be received at least (30) days prior to the date of departure. Reservations made less then (30) Days to the date of departure must be accompanied by payment in full. If final payment is not received within the required period, Mexico Yacht Vacation reserves the right to cancel any such reservations without prior notice and without right of deposit recovery for the client, as indicated in this section of terms and conditions.

Airfare:

The clients themselves do all Airfare bookings. Mexico Yacht Vacation does not book any airfare but can suggest a travel agent if needed. All Mexico Yacht vacation trips start and end in San Carlos. We strongly recommend clients to purchase traveling and flight cancellation insurances incase of any unforeseen circumstances that are beyond Mexico Yacht Vacation, or anybody else's control. The client before booking must sign this term and conditions form. Mexico Yacht Vacation will keep the terms and conditions signed form on file for any future reference.

Charter Prices do not include transportation to San Carlos or airfare to and from Hermosillo or Guaymas. Transportation from the Hermosillo International Airport is included with any of our three day or longer vacation packages. Any vacation package of less than 3 days will include transportation from the Guaymas airport only.

Mexico taxes are included in your package quote and paid for by Mexico Yacht Vacation.
